In 2015, more than 1,900 animals received vital services from the Shelter. This includes 595 animal adoptions, 701 dogs and cats spayed or neutered, 170 lost or impounded pets reunited with their families, 348 animals rescued from overpopulated regional animal shelters and over 9,000 pounds of food provided through the Paws for Hunger pet food bank. In addition, more than 850 children received humane education programming through the Shelter's outreach efforts.

Additionally, The Animal Shelter is engaged in a multi-year capital campaign to build a new regional animal welfare campus and adoption center. The large increases in revenue and net assets (continued on schedule O)

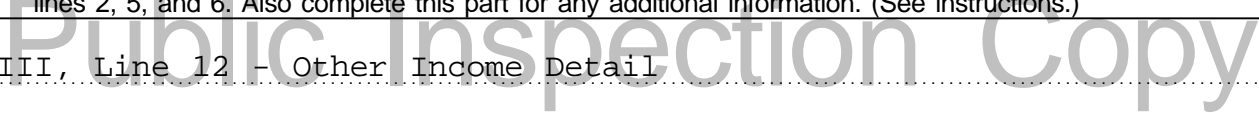

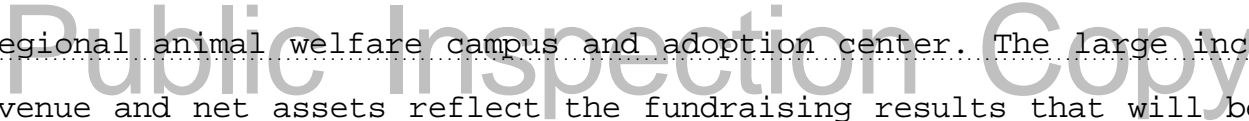
